# **Fire-raiser** jailed over house blaze

A PENSIONER who set fire to her own home endangering the lives of herself, her husband and the neighbours who rescued her has been jailed.

Christina Dewar (62) was sentenced to eight months when she appeared at Inverness Sheriff Court on Tuesday, having previously been found guilty of setting the fire at her home in Mackay Road, Inverness on April 8 last year.

Sheriff Gordon Fleetwood had heard how she used lighter fuel to ignite incontinence pants and other material at the back door of the house and refused to leave the property despite the attempts of others to rescue her and her husband. Charles, who the trial also heard she had wanted to die. Sentence had been deferred

for reports and the case had to be continued twice because Dewar was attending hospital. She was finally sentenced this week, having come straight the lives of others." the lives of others." The trial had heard how a from hospital for the hearing.

Solicitor Duncan Henderson said she had been drinking on

the day of the offence. "She was in very low spirits, having been diagnosed with breast cancer," he said.

He asked the sheriff to consider a community-based sentence that would enable her to address her alcohol problems as well as take account of her previously unblemished record.

Sheriff Fleetwood, however, ruled that custody was the only appropriate disposal.

He told Dewar: "I have to accept, and do accept, your spirits were low. But I must set against that that you endangered you and your husband and two other innocent and wanted them both to die.

15-year-old was among those who rescued the couple.

He had told Dewar's trial how he and neighbours saw smoke coming from the property.

He said he told Dewar and her husband to get out, but they weren't moving and he

thought they were both drunk. "We tried to stand Christina up but she was resisting the attempts," he said.

The couple were eventually carried out and at Raigmore Hospital Dewar told a nurse she had poured lighter fuel onto incontinence pants and set them alight.

PC Michael Heath also told the trial that Dewar informed him she hated her husband
